| 2 | To amend and reenact R.S. $28:53(B)(1)$, (F), (G)(2), and (J)(1) and (3) and to enact R.S. |
| 3 | 28:53(B)(4), relative to mental health admissions by emergency certificate; to allow |
| 4 | for the actual examination of a patient conducted by a health care provider, parish |
| 5 | coroner, or authorized physician to be conducted by telemedicine utilizing video |
| 6 | conferencing technology; to make certain requirements for telemedicine |
| 7 | examinations; to provide for procedures related to the issuance of a certificate; to |
| 8 | require an in-person independent examination by the coroner in certain cases; and |
| 9 | to provide for related matters. |
| 10 | Be it enacted by the Legislature of Louisiana: |
| 11 | Section 1. R.S. 28:53(B)(1), (F), (G)(2), and (J)(1) and (3) are hereby amended and |
| 12 | reenacted and R.S. 28:53(B)(4) is hereby enacted to read as follows: |
| 13 | §53. Admission by emergency certificate; extension |
| 14 | * * * |
| 15 | B.(1) Any physician, psychiatric mental health nurse practitioner, or |
| 16 | psychologist may execute an emergency certificate only after an actual examination |
| 17 | of a person alleged to be mentally ill or suffering from substance abuse who is |
| 18 | determined to be in need of immediate care and treatment in a treatment facility |
| 19 | because the examining physician, psychiatric mental health nurse practitioner, or |
| 20 | psychologist determines the person to be dangerous to self or others or to be gravely |
| 21 | disabled. The actual examination of the person by a psychiatrist may be conducted |
| 22 | by telemedicine utilizing video conferencing technology provided that a licensed |

| 1 | health care professional who can adequately and accurately assist with obtaining any |

| 2 | necessary information including but not limited to the information listed in R.S. |

| 4 | conference. A patient examined in such a manner shall be medically cleared prior |
| 5 | to admission to a mental health treatment facility. Failure to conduct an examination |
| 6 | prior to the execution of the certificate will be evidence of gross negligence. |

| 8 | (4) In case of an emergency certificate issued pursuant to an examination |
| 9 | conducted by telemedicine pursuant to Paragraph (1) of Subsection B or Paragraph |

| 11 | during the actual examination shall be responsible for obtaining, recording, and |
| 12 | attaching to the emergency certificate the following information regarding the video |
| 13 | conference: |
| 14 | (a) The date. |
| 15 | (b) The starting and ending times. |
| 16 | (c) The names of all persons who were in the room and the type of license |
| 17 | issued to the health care professional. |
| 18 | (d) The physical address of both the examining psychiatrist and the patient |
| 19 | when the video conference was conducted. |

| 21 | F. An emergency certificate shall constitute legal authority to transport a |
| 22 | patient to a treatment facility and shall permit the director of such treatment facility |
| 23 | to detain the patient for diagnosis and treatment for a period not to exceed fifteen |
| 24 | days, and to return the patient to the facility if he is absent with or without |
| 25 | permission during authorized periods of detention. If necessary, peace officers shall |
| 26 | apprehend and transport, or ambulance services, under appropriate circumstances, |
| 27 | may locate and transport, a patient on whom an emergency certificate has been |
| 28 | completed to a treatment facility at the request of either the director of the facility, |
| 29 | the certifying physician, psychiatric mental health nurse practitioner, or psychologist, |
| 30 | the patient's next of kin, the patient's curator, or the agency legally responsible for |

| 14 | independently examined by the coroner or his deputy who shall execute an |

| 17 | examination by the psychiatrist in Paragraph (1) of Subsection B of this Section is |
| 18 | conducted by telemedicine, the seventy-two-hour independent examination by the |
| 19 | coroner shall be conducted in person. |

| 21 | J.(1) Upon the request of a credible person of legal age who is financially |
| 22 | unable to afford a private physician or who cannot immediately obtain an |
| 23 | examination by a physician, the parish coroner may render, or the coroner or a judge |
| 24 | of a court of competent jurisdiction may cause to be rendered by a physician, an |
| 25 | actual examination of a person alleged to be mentally ill or suffering from substance |
| 26 | abuse and in need of immediate medical treatment because he is dangerous to |
| 27 | himself or others or is gravely disabled. The actual examination of the person by a |
| 28 | psychiatrist may be conducted by telemedicine utilizing video conferencing |
| 29 | technology provided that a licensed health care professional who can adequately and |
