**PLAINTIFFS' SUPPLEMENTAL RESPONSE IN OPPOSITION TO  
ASTRAZENECA'S MOTION TO EXCLUDE TESTIMONY OF PLAINTIFFS'  
GENERIC AND CASE SPECIFIC WITNESSES**

Pursuant to this Court's recent directive that any amended expert declaration by Donna K. Arnett, Ph.D., M.S.P.H ("Dr. Arnett") be filed by March 7, 2009, Plaintiffs submit this Supplemental Response in Opposition to AstraZeneca's Motion to Exclude Testimony of Plaintiffs' Generic and Case Specific Witnesses (Doc. 1112) with the Second Declaration of Donna K. Arnett, Ph.D., M.S.P.H, attached hereto as Exhibit 1, and excerpts from Dr. Arnett's deposition which are referenced in her Second Declaration, attached hereto as Exhibit 2.<sup>1</sup>

Dr. Arnett's Second Declaration was recently filed in *Nina Scaife vs. AstraZeneca LP, AstraZeneca Pharmaceuticals LP*, Case No. 06C-04-218, in the Superior Court for the State of Delaware, New Castle County, in response to AstraZeneca's Motion *in Limine* to Exclude Expert

As AstraZeneca has designated a portion of Dr. Arnett's Second Declaration as confidential, in conjunction with this filing, Plaintiffs also file their Unopposed Motion to Seal the redacted portion of Dr. Arnett's Second Declaration.

Testimony of Donna K. Arnett, Ph.D., M.S.P.H. In her Second Declaration, Dr. Arnett does not change the opinions contained in her Expert Report or first Declaration, which are attached as Exhibit 3 to Plaintiffs' Memorandum of Law in Opposition to AstraZeneca's Motion to Exclude the General Causation Testimony of Plaintiffs' Generic and Case Specific Witnesses. Rather, Dr. Arnett further elaborates on her qualifications, the methodology she applied in formulating her opinions in this litigation, and responds to AstraZeneca's criticisms of her methodology. As such, Plaintiffs believe this Second Declaration will be of use to the Court in its consideration of AstraZeneca's Motion to Exclude Testimony of Plaintiffs' Generic and Case Specific Witnesses.
