#### Jim Gottstein

In 1982, when I was 29, I got into a situation where I didn't sleep for days. I tried to do too much. I went psychotic. When I heard someone coming down the hall, I thought the devil was after me and jumped out of my father's second-fixor window in the wee hours in my underwear (since I knew how to do a parachute landing fall, I really idn'th think I would get hurt, and I didn'th. After I was captured, I was taken to Alaska Psychiatric Institute (API) in a straight-jacket, and pumped full of a whole lot of Mellaril.

Prior to this, I was a practicing attorney. I had gone through college in three years at the University of Oregon by averaging 21 hours a term, rather than the normal 15 hours. After graduating from college I was admitted to Harvard Law School. Since graduating from law school, I had been practicing law in Anchorage. Before my episode I had never run into a situation where I couldn't do all the work that "needed to get


When I woke up in the hospital, still groggy from the medication that forced me (finally) to skeep, a young man was sitting in a chair at the foot of my bed with a clipboard. He asked me what day it was. I asked him how long I had been askep. He worked down that I didn't know what day it was. Things didn't get better from there. I was somewhat belligerent since I was used to being free and being able to make my own decisions.

- Six Fold Increase in Disability Rate Attributed to Mental Illness

#### Finland Open Dialogue Approach: **Five Year Study of Psychotic Patients**

- 82% did not have any residual psychotic symptoms;
- 86% had returned to their studies or full-time jobs;
- only 14% were on disability; and
- 71% never took any antipsychotic medication.

#### WARNING

- · Quitting Psychiatric Drugs Can Be Very Dangerous/Should be Done Slowly Under the Supervision of a Physician
  - Withdrawal Often Causes Psychiatric **Symptoms**
  - Often accompanied by Adverse Physical Effects

#### **Alaska Peer Support** Consortium

The Alaska Peer Support Consortium is a network of Alaskan behavioral health peer support organizations. The Consortium fellows meet face to face three times yearly. We get to know each other's history, mission, flavor, and dreams, address fundling issues, organize peer support education and training, and share information. The fellowship develops the assumption of commonness rather than the assumption of isolation and separation. By pooling energy and information, there is a wider base from which to grow. In finding our common denominators, our needs become less personal, more general, and therefore more possible for the behavioral health system to effectively respond. A spiral of energy emerges in which our collected voice becomes clearer. The more stable and unified peer directed organizations become, the stronger and richer the Alaska behavioral health system is for all.

#### Soteria-Alaska

- Non-coercive, Non-Drug option for Newly Diagnosed with Psychotic Disorder.
  - Be With, Not Do To
  - Expect Recovery
  - Let People Be "Delusional"
  - But Insist on Safety/Responsibility
- · Replicate Original Soteria-House
  - 6-8 People
  - Two staff at all times.

#### PsychRights in Alaska

- Myers (2006)
  - Best Interests
  - No Less Intrusive Alternative Available
- Wetherhorn (2007)
  - Unable to Survive Safely in Freedom
- WSB (2008)
  - Judge has to be given transcript or listen to recording of hearing
- Bigley (2009)
  - "Available" Alternative means "feasible" --Have to provide or let go.
  - Petition has to include information on proposed drug as well as alternatives.


