Subject: Response to FDA Seroquel letter

At yesterday's US Product Team meeting, I was actioned to pull together the responsible parties to address the FDA's inquiry regarding hyperglycemia and other related issues from the Seroquel experience (FDA letter attached).

Please note that this inquiry includes preclinical and clinical trial experience (NDA reports), postmarketing reports, and any exchange of correspondence with other regulatory authorities. They also suggest that we consider collaborating with organizations having large pools of treated patients (HMOs or VA databases).

FDA is seeking a complete and timely response within 3 months.

Please begin to develop a plan to address this inquiry from your area of responsibility. My AA Yolonda Evans will be seeking a time when we can discuss our plan of attack, perhaps via a teleconference or video. Perhaps we can touch on this topic at the joint global/US product team meeting next week at APA/Chicago; I think we still need to meet separately to agree on a plan and timeline, and assure we have adequate resources.

If you believe that additional staff should be pulled into this exercise, please feel free to share this note, and inform me of their participation.



If you wish any clarification from the FDA on the issues that they have raised, please let me know, and I can set up that interaction.
