PETITION FOR INITIATION
OF INVOLUNTARY COMMITMENT

Rachael Humphreys, petitioner alleges that the respondent is mentally ill and as a result of that condition is gravely disabled or presents a likelihood of causing serious harm to himself/herself or others.

Petitioner respectfully requests the court to conduct or to arrange for a screening investigation of the respondent as provided in AS 47.30.700.

If this investigation results in a determination that the respondent is mentally ill and as a result of that condition is gravely disabled or presents a likelihood of causing serious harm to himself/herself or others, the petitioner requests that the court issue an ex parte order for temporary custody and detention for emergency examination or treatment.

Respondent was taken into emergency custody by _____ under AS 47.30.705. The Peace Officer/Mental Health Professional Application for Examination is attached. Petitioner respectfully requests that the court issue an ex parte order authorizing hospitalization for an evaluation as provided for in AS 47.30.710.

Facts in support of this request are as follows:

1. The respondent named above is 51 years of age and resides at 2607 W. 33rd #3 Anchorage, Alaska.

2. The facts which make the respondent a person in need of (a screening investigation) (hospitalization for evaluation) are: Refuses prescribed medication

Refuses medical treatment

At risk of eviction due to threatening Landlord + tenants

Poor Personal Hygiene ie: not bathing, not eating, digging through garbage dumpster bringing into home, placing food throughout the house to feed critters, feeds strays + wild animals off front porch
Loses money, keys to home -accusing neighbors of stealing items
would prefer to be homeless / living in car
