REQUEST FOR STATUS HEARING


Peter C. Gøtzsche, MD, by and through counsel, requests a status hearing with respect to implementation of the Supreme Court's October 16, 2017, Order pertaining to Dr. Gøtzsche's June 20, 2016 request for information (Information Request).

The response of the Alaska Psychiatric Institute (API) to Dr. Gøtzsche's, Information Request, and the responses by API and the Public Defender Agency to Dr. Gøtzsche's Original Application to the Supreme Court reveal their objections primarily revolve around (a) what notice should be given to affected respondents, if any, and (b) preserving the confidentiality of respondents whose files may be impacted by the Information Request.

As a physician, Dr. Gøtzsche is used to respecting patient confidentiality, but recognizes these concerns. A status conference may allow the Court to arrive at an approach to these two issues much more quickly than otherwise if it is inclined to grant the Information Request.


