offense unless it is an address used to identify the place of the crime or it is an address or telephone number in
a transcript of a court proceeding and disclosure of the information was ordered by the court. I further certify,
pursuant to App. R. 513, that the font used in this document is Arial 12.5 point.

13 The Public Defender Agency was served with the request filed on behalf of
14 Dr. Peter Gotzsche to obtain access to confidential court files in civil commitment
15 matters. To date, the Public Defender Agency has not been formally appointed in
16 this matter. The Public Defender disagrees that the Alaska Supreme Court should
17 address the merits of Dr. Gotzsche's request and reiterates its previous position that
18 individual respondents are entitled to notice and an opportunity to object to
19 disclosure.¹ Dr. Gotzsche should direct his request to the trial court judge in
20 accordance with this Court's order of October 16, 2017.


