No. 113 (Preliminary Injunction Motion), and that it be held as soon as possible. Since the Motion for Preliminary Injunction is against only two defendants, both of whom are represented by the same attorney(s), there is no reason to push the argument out as far as the defendants propose with respect to their four motions to dismiss, Dkt. No. 131.

Motions for preliminary injunction are inherently expedited motions and for the reasons stated in the Motion for Preliminary Injunction, Dkt. No. 113, and reply, Dkt. No. 132, the federal government is facing irreparable harm due to the continuing violation of federal law which is the subject of the motion. Therefore, PsychRights respectfully requests argument on its Motion for Preliminary Injunction, Dkt. No. 113, be granted and scheduled to take place as soon as possible.
