The names of certain practitioners may appear more than once due to the fact that this report contains compiled data from multiple vendors who process payments on Lilly's behalf.

Eli Lilly and Company has sponsored other business entities who conduct research or provide medical education programs where payments may have been made by those entities to Minnesota practitioners. In these cases, the practitioners are not chosen by Lilly and the compensation to the practitioners is not directed by Eli Lilly; therefore, these payments are not reflected in the attached reports.

Please note that Lilly is party to a co-promotion agreement with Takeda Pharmaceuticals for a pharmaceutical product called Actos (pioglitazone HCl). Lilly is also part of a joint venture with ICOS (Lilly ICOS LLC) to promote a pharmaceutical product called Cialis® (tadalafil). Payments made by Lilly on behalf of Lilly ICOS are included in this report.

Within the attached report, you will find an addendum to the report filed in 2003 by Eli Lilly and Company for calendar year 2002. In gathering data for the 2004 report, we found some payments to healthcare practitioners that were inadvertently left out of our report last year. These payments are appropriately marked "2002 Addendum" at the top.
