Re: Minnesota Expense Reporting Statute

Dear Mr. Holmstrom,

Attached is a report that includes, to the best of our knowledge, all payments, honoraria, reimbursement, and other compensation authorized by the State of Minnesota Legislature under section 151.461, clauses (3) to (5), paid by or on behalf of Eli Lilly and Company to licensed practitioners in Minnesota during the 2004 calendar year. The names of certain practitioners may appear more than once due to the fact that this report contains compiled data from multiple vendors who process payments on Lilly's behalf.

Eli Lilly and Company has sponsored other business entities who conduct research or provide medical education programs where payments may have been made by those entities to Minnesota practitioners. In these cases, the practitioners are not chosen by Lilly and the compensation to the practitioners is not directed by Eli Lilly; therefore, these payments are not reflected in the attached reports.

Please note that Lilly is party to a co-promotion agreement with Takeda Pharmaceuticals for a pharmaceutical product called Actos (pioglitazone HCl). Under that agreement, Takeda is responsible for making certain payments to physicians on behalf of the companies for services that may be covered under section 151.461. Because those payments come from Takeda, they are not within the scope of Lilly's attached report. Lilly is also part of a joint venture with ICOS (Lilly ICOS LLC) to promote a pharmaceutical product called Cialis[®] (tadalafil). Payments made by Lilly on behalf of Lilly ICOS are included in this report. Lilly also co-markets a pharmaceutical product called Byetta[™] (exenatide) injection through a contractual alliance with Amylin Pharmaceuticals, Inc. Payments made by Lilly on behalf of the Amylin/Lilly Alliance are included in this report.
