

AstraZeneca does not publicly release this information or the documents that were used to generate this report. Further, release of the information in this report, either individually or in aggregate, may harm AstraZeneca, giving AstraZeneca's competitors information that may give them a competitive advantage and undermining the company's relationship with contractors and consultants.

This report reflects certain payments made by AstraZeneca to practitioners in Minnesota. AstraZeneca occasionally makes payments to institutions and business entities which, in turn, may make payments to Minnesota practitioners. For example, AstraZeneca has arrangements with universities and other business entities to conduct research or provide services under which payments may be made by the entity to Minnesota practitioners. The company also has arrangements with sponsors of independent education activities. In these cases, the independent education provider may make payment to the practitioner who serves in a faculty capacity. As the independent education providers act outside the control or influence of AstraZeneca, any payments by these providers to practitioners are not listed in this report.
