Hi Laura, Erin & Tim,

Tim, in case you didn't know, the Superior Court issued a new forced drugging order on Tuesday against Mr. Bigley. You can find the decision at

The Superior Court stayed the decision until December 15th, to "give API an opportunity to allow the Supreme Court to review its stay in light of the briefing and oral argument in the pending appeal as supplemented by this Court's findings." P.33 Unfortunately, this creates problems because the Superior Court's stay expires before oral argument in S-13116 and needs action by either the Superior Court or the Supreme Court to remain in effect. I, think the new forced drugging petition was improper, constituting contempt of court.

What I'd like to do is stipulate in the Superior Court that the stay will remain in effect until the Supreme Court rules on it. Less preferable is that we stipulate to the stay remaining in effect until the earlier of January 5, 2009, or the Supreme Court rules on it. Absent an agreement today, I expect to be filing motions regarding the stay to both the Superior Court and the Supreme Court on Monday.

I am currently scheduled to be out of town the week of December 7th for a trip that is very important to me and therefore will appreciate it if we can do things in a way that accommodates that. I have mapped out a sequence and timing that should be able to do so.
